H. COMMISSION AND COMMITTEE REPORTS FOR DISCUSSION, CONSIDERATION AND, IF SO DETERMINED, ACTION UPON

1. Safety Commission

a. Briefing on Village Security by Lake County Sheriff

Sergeant Sara Balmes of the Lake County Sheriff's Department and Mettawa's Liaison Officer distributed service calls summaries to the Village Board. She reported the greatest area of service calls was traffic stops and vehicle accidents given the amount of traffic that travels through the Village. The Department does a large number of business checks and reminded residents to call the department when needed. Resident Tom Heinz reported a significant amount of speeding was occurring on St. Marys Road and asked that speed enforcement be addresses. He offered the use of his driveway for this purpose. Trustee Brennan expressed her thanks to the Sheriff's Department for their handling of her husband's recent hit and run accident at the Costco gas station.

2. Finance Committee

a. Recommendation for Approval of an Ordinance Authorizing the Levy and Collection of Taxes for the Corporate and Municipal Purposes for the Village of Mettawa for the Year 2015

Trustee Maier reported the Finance Committee recommends approving the annual tax levy ordinance. There are no changes from last year. In fact, the Village has maintained its corporate tax levy the same for 17 years.

b. Recommendation for Approval of an Ordinance Abating Certain Additional Taxes Levied by the Village of Mettawa Pursuant to Ordinance No. 692 for the Year 2015

Trustee Maier reported that the Committee recommended approval of the tax abatement ordinance for the general obligation bonds for the Oasis Park purchase since general revenues would be used to pay the debt.

c. Recommendation to Approve an Amendment to the Agreement with Howe Security

Trustee Maier reported the Committee recommended approval of the amendment to the agreement which results in a savings of \$3,000 per year and puts a new truck on the road. The Village will pay half of the cost of the truck and gasoline. Trustee Pink indicated it removed the \$.45 per mile reimbursement. Howe had requested consideration of an hourly rate increase for the next 3 years. The Village has approved increases of about 4% for the last three years. The Committee recommended no change for 2016 and would review again for 2017 and 2018.

3. Public Works Committee

a. Updates

Trustee Armstrong reported that the Village Engineer would be taking cores on Old School Road in advance of the repaving project. Village Engineer Anderson said that it would be done this week. Trustee Armstrong advised that he had received an inquiry from Robert Spiglanin on South St. Marys Road regarding water availability. Since we will be obtaining bids for the water main extension for St. Marys and Old School Road early next year, Trustee Armstrong recommended that we take the unit prices in the bids and use the numbers to update the costs for other areas in the Village. It has been about five years since these areas were estimated. He also reported that we are working on the Village Hall documents for the special meeting in January. The striping project for Riverwoods Blvd. will be held off until next year.

4. Parks and Recreation Committee

a. Updates

Trustee Towne advised the December meeting had been canceled due to the holidays. The next meeting will be held on January 13th. Work on trails and parks will be addressed and the Committee is looking forward to an active 2016.

5. Safety Commission

a. Status and Activity Update

Trustee Pink reported that everything was pretty normal in the Village and things have been quiet.

6. Zoning, Planning and Appeals Commission

a. Findings of Fact and Recommendation, Case No. 15-A-1, Application by the Village of Mettawa for a Comprehensive Zoning Map Amendment Regarding the OS Open Space District.

Mayor Urlacher said that Chairman Krusinski was in the audience and the Village Attorney Smith would provide the report. Attorney Smith reported that the Zoning, Planning and Appeals Commission met on December 1st to review two matters. The special use ordinance amendment submitted by Amy and Tim Farmer, that received a denied recommendation by the Commission, had been withdrawn by the applicants. The other matter dealt with the Village Board referral of properties to be rezoned to the Open Space District that was created by the Village Board in 2014. The new district seeks to offer greater protection from development. The properties are owned by the Village, Forest Preserve and Enclave Home Owners Association. The Village Board received the Findings of Fact report, 30 page public hearing transcript and color zoning map which shows the open space property in a green color. The Enclave HOA expressed support for the rezoning through a letter submitted to the Village and the Executive Director of the Lake County Forest Preserve verbally expressed the District's support to the Village Administrator.

Trustee Armstrong asked about a parcel of property on Route 60 near the Des Plaines River that was shown in green on the map that he thought was privately owned residential property and not owned by the Forest Preserve. After a review of the map, it was determined that the property in question is owned by the Forest Preserve.

Trustee Towne pointed out that we left out two Village owned properties in subdivisions from the rezoning on Oak Hill and in Riverside Preserve even though the properties are being maintained as open space. Village Administration Irvin agreed and said that since they were small lots in subdivisions it was recommended that they not be rezoned, but could still be maintained as open space parcels.
