# H. COMMISSION AND COMMITTEE REPORTS FOR DISCUSSION, CONSIDERATION AND, IF SO DETERMINED, ACTION UPON

## 1. Finance Committee

a. Recommendation to Approve an Ordinance Declaring Surplus Funds and Directing Local Tax Reimbursements Pursuant to the Illinois fiscal Responsibility Law

Mayor Urlacher said the 2017 Tax Rebate is higher by \$150,000 from the 2016 rebate program. Trustee Bohm asked Trustee Maier to elaborate on the how the tax rebates are calculated. Trustee Maier said we start with the cap of \$500,000. When a resident tax rebate application is received, the Village verifies the taxes each applicant resident has paid for that year and a percentage of that total is what the resident will receive as their rebate amount.

Trustee Sheldon added the rebate is not a tax rebate because residents have paid their property taxes. The Village Tax Rebate Program is a profit the Village has allotted. Trustee Maier said the Village receives tax revenues from many sources. The Villages operating expenses are kept at a minimum. As a result, the surplus funds from the operating expense account are than presented as a surplus to the Village.

The tax rebate should not be assumed as a guarantee, it is only a guarantee if there are surplus funds.

#### b. Other Matters

Trustee Maier said the Village audit has commenced and the required documents have been submitted. The audit is going smoothly; therefore the audit should be done by October. Trustee Maier said once the audit is complete and the final reports have been received they will be posted. The reports will be posted on the Village website along with the Illinois Comptroller's website.

Trustee Maier said this month's Treasurer's Report is the first for the new fiscal year as a result, the monthly bills and activity reported are lower than normal. This trend is normal for the start of the fiscal year.

#### 2. Public Works Committee

## a. Update on Potential Water Main Extension

Trustee Towne said a study of the north end residents is being conducted to determine the cost on the water main extension. The option being studied is running the water connection south of Route 176 versus south of Rockland through Libertyville. The residents on the south end of Route 60 and St. Marys Road are also being studied on options for their water main connection. Trustee Towne added ongoing information will be provided as the Committee conducts its studies.

# b. Update on the Village Street Lighting Study

Trustee Towne said in a prior meeting it was determined that the following corners; St. Marys Road,/Alexandra Drive and Riverwoods/Shagbark and St. Marys/Sanctuary needed lighting. As a result, arm lighting will be added to two of the existing poles and the third location will be completed upon receiving cost details.

# c. Update on amending SSA#3 to Support Road Repairs

Trustee Towne said the road repairs are for Riverwoods Boulevard from Route 60 to Bradley Road. Hamilton Partners is currently reviewing the options on how to support the required funds for the road repairs. Village Engineer Anderson said there is a repair program the Village can submit to receive support on the road repairs. Village Engineer Anderson will continue to research this program to determine if the Village qualifies or if it is conducive to participate.

d. Recommendation for Approval of the 2017 Prevailing Wage Ordinance

Trustee Towne said the filing of the prevailing wages ordinance is part of the state requirements.

e. Update on the Mosquito Abatement Program

Trustee Towne asked Village Clerk Gallo if Clarke has sprayed the Village. Village Clerk Gallo said no invoice has been submitted to confirm the spray.

Village Administrator Irvin said the individual lot spray program does address ticks; however the Village spray does not. Clarke Mosquito representative George Balis will attend the July meeting to speak about the Village spraying program.

#### f. Other Matters

Trustee Towne asked Village Engineer Anderson when he anticipated starting on Mr. Buell's culvert repairs. Village Engineer Anderson said he anticipated receiving the parts next week. Weather permitting they will start the repair.

#### 3. Parks and Recreation Committee

a. Update on the Trail Maintenance and Drainage Issues

Trustee Sheldon said Army Corps is close to approving the work to be done at the Oasis Trail. Village Engineer Anderson added they are still waiting for the final sign-off from Army Corps and they have no additional requirements.

Mayor Urlacher asked Trustee Sheldon if anyone has contacted Chicagoland Paving Company to complete the repairs. Trustee Sheldon replied the Board agenda item c is to make the recommendation for the approval for \$5,500 to complete the grading and drainage.

b. Recommendation to Approve Tallgrass Grading & Debris Removal Works With the Oasis Park Grant Project in the Amount of \$1,150

Trustee Sheldon said additional grading and removal of debris was needed at the Oasis Park. As a result, the Tallgrass invoice for \$1,150 will require approval. The grant area was approved by Storm Water Management and Teska.

c. Recommendation to Approve a \$5,500 Change Order to Chicagoland Paving for Additional Drainage Work on the Route 60 Trail Extension

Trustee Sheldon said this additional drainage work is part of the Route 60 trail installation.

#### d. Other Matter

Trustee Sheldon said the removal of buckthorn project will be ongoing.

Resident Pat Cork (26453 N. Farewell Road) asked to discuss the equestrian sign update. Trustee Sheldon said once the trail on Route 60 is complete, the equestrian sign will be posted accordingly.

Resident, Pat Cork (26453 N. Farwell Road) asked if the Oasis Park trail will be completed for the July 4<sup>th</sup> weekend. Trustee Sheldon said Chicagoland Paving will be contacted the next business day, however, no guarantees can be made on a completion date.

# 4. Safety Commission

# a. Status and Activity Update

Trustee Pink said the Fire Protection District has not received the address signs to be posted. The residents will receive a two week notice prior to the work being commenced.

Trustee Pink said she is currently surveying the Village street signs and horse crossing signs. As a result, new signs may be needed due to the large stables being built on Bradley Road and Old School Road. Trustee Pink spoke to Ann Maine the Lake County Representative about the Everett Road Trail and inquired if any horse-crossing signs were going to be placed on the roundabout. No horse crossing sign will be placed on Everett Road and St. Marys. Ms. Maine indicated she is not aware what type of sign will be posted at the Daniel Wright Woods as well. This sign would be provided through the Lake County Division of Transportation.

Trustee Pink spoke with the Village Attorney Ferolo regarding the bikers on the road. The consensus was to address the bikers who are riding three across on the road, when they have stopped. Village Attorney Ferolo added Howe Security are not peace officers and are not authorized to stop bikers. Legally the Sheriff's officers only have the right to stop the bikers not Howe Security. Trustee Pink discussed these actions with Rick from Howe Security.
