The Buzz

New grant reimburses Mettawa residents for buckthorn removal

This cost-share opportunity covers 50% of approved expenses (up to \$3000) for removal of buckthorn and other invasive shrubs

The health of Mettawa's woodlands is so important that the U.S. Forest service is now offering financial support to residents who remove buckthorn, honeysuckle and other invasive shrubs and tree species with qualified, pre-approved contractors. Through a new cost-share grant administered by Openlands, and in partnership with the Village of Mettawa and Mettawa Open Lands Association (MOLA), approved applicants will be reimbursed for half of their costs, (up to \$3000). \$20,000 has been allocated for Mettawa; this means that a total of \$40,000 will be spent if all of the grant funds are used.

We encourage interested residents to apply early. Winter is the only appropriate season for much of this work and the funds will be distributed on a first-come, first-serve basis. *If you're interested in taking advantage of this program, here are 3 simple steps:*

1) Schedule an ecological consultation. This free session with Openlands (see below) is no-obligation. An ecologist will spend an hour with you on your property to assess woodland health, learn about your landscape, and provide a summary report. You may find this session helpful even if you do not apply for financial support.

2) Hire a contractor. Evaluate proposals from your choice of three pre-approved Openlands contractors.

Beautiful Fall

I hope that all of you are enjoying fall and staying safe.

I'd like to remind everyone about the upcoming elections on November 3,

2020. Early voting is available at many local sites, including at the Lake Forest City Hall and the Lake County Central Permit Facility. These sites are open Monday through Friday 8:30 a.m – 5:00 p.m. and Saturday – Sunday 9:00 a.m – 5:00 p.m. through November 1, 2020. There are four state mandated early voting sites in Lake County that will provide extended hours on November 2, 2020.

Vote by mail ballots may also be dropped off postage-free in multiple drop box locations. Most of these are available until November 1, but four are available through November 3. For example, the drop box located outside the entrance to the Juvenile Branch Court at 24647 N. Milwaukee Avenue in Vernon Hills is available 24/7 until it is locked at 7 p.m. on November 3.

3) Get reimbursed up to \$3000. Once your project is approved and completed, you will be reimbursed by Openlands for half of your costs, to \$3000.

Healthy woodlands provide many benefits for people. They help promote flood control, clean air, cooler temperatures, clean water, beauty, and stress relief. They also provide an environment where wildlife can thrive. Invasive shrubs and trees reduce these benefits and cause long-lasting damage to soil, wildlife and the entire eco-system.

Because Mettawa is located within Lake County's largest remaining woodland, our residents' actions can make a big impact on the health and strength of this living treasure.

Stormwater management study

At its October meetings, the Village Board approved the selection of Hey & Associates to undertake a comprehensive study stormwater management in the Village. In September, the Public Works Committee (PWC) reviewed materials from eight firms and interviewed four finalists. The PWC unanimously voted to recommend Hey & Associates.

This highly qualified, Volo-based company has successfully completed multiple projects in and around Mettawa, including work for the Lake

County Forest district at the Adlai E. Stevenson Home Preserve and other adjacent forest preserves. The company's Principal, Tom Polzin also lives in our area.

The Village will meet with Hey & Associates to provide the information needed to scope and price the comprehensive project.

Once approved, the study will proceed and should examine overall stormwater management with careful review of culverts, detention ponds and other relevant areas. It will also identify problematic areas, benefits of mitigation and potential costs. The firm will also assist the Village in applying for relevant grant funding.
