C. APPROVAL OF MINUTES

1. Regular Meeting of the Mayor and Board of Trustees: December 18, 2012

Mayor Ray informed the Board that the tentative forecast for the fiscal year end is a positive \$630,000.00 with one-time significant expenses for: new roads, trails, culvert repairs, razing of the Korhumel house and barn and a 10-times tax rebate.

Brief discussion ensued.

The Clerk read the letter from Ven Hyeji and the Mayor directed that it be placed on file.

G. COMMISSION AND COMMITTEE REPORTS FOR DISCUSSION AND CONSIDERATION AND, IF SO DETERMINED, ACTION UPON

- 1. Finance Committee
 - a. Update: Lake Forest Sales Tax Payment

Trustee Maier updated the Board on the continuing issue with the Illinois Department of Revenue, City of Lake Forest and Mettawa regarding Oasis Sales Tax Revenue and payment of a portion of that tax revenue to Lake Forest per agreement. He informed the Board that there has been no movement on the issue.

Village Attorney Ferolo informed the Board that he is waiting for a response to the letter he sent the State of Illinois. Mayor Ray stated that he has had contact with the Mayor of Lake Forest regarding a planned meeting. Discussion continued regarding the possibility of a village sales tax so that the Village can obtain detailed information from the State. Mayor Ray directed the Village Attorney to draft a sales tax ordinance for the next meeting

- b. Other Matters
 - i. Trustee Lane questioned the James Anderson Company charges for Around the Town meeting prep of over \$2,000.00 a month. Mr. Anderson of James Anderson Company stated that Village Engineer works almost full time for the Village, and that he would look into the charges.

Discussion ensued regarding invoice review and it was agreed that the James Anderson Company invoices should go to Trustee Town first.

Mayor Ray questioned whether a retainer might be a good option

- ii. Trustee Lane asked how many months does the Village pay for salt. Trustee Armstrong responded five months
- iii. The Finance Committee asked who LifCo was and they were informed that LifCo was the company that put in the Whippoorwill Trail.

- v. Trustee Maier informed the Board that the 2012 audit is complete, but that they need "representation" letters from Klein, Thorpe & Jenkins and Raysa Zimmermann.
- vi. Mayor Ray asked that large projects be reconciled, bid vs. actual.
- 2. Public Works Committee
 - a. Update: Meadowoods Paving and Shoulders

Trustee Armstrong informed the Board that the final invoice from Curran Construction needs final resolution

- b. Trustee Armstrong informed the Board that Ciorba Group is working on estimates for the Bradley Road re-surfacing project.
- c. Trustee Armstrong informed the Board that the committee is working on a Special Service Area, for water in the St. Marys/Little St. Marys/W. Old School area.
 In addition he reported that the Sanctuary Lane private water line is progressing.
- d. Trustee Towne informed the Board that estimates for remedial work on the future Village Hall are being put together for the next Board meeting in February.
- e. Trustee Armstrong also noted that there have been street light outages on Riverwoods Road and requested that anyone who sees an outage report it immediately.
- f. Discussion ensued regarding making sure that money billed by James Anderson Company for Special Service Area work, is actually being billed back to the Special Service Area. Trustee Maier stated that the Finance committee would look in to the issue. He agreed also to look into permit in/permit out charges.
