## Adlai Stevenson II Farm in Mettawa named as new national historic landmark

On April 23, 2014, Mettawa's Adlai Stevenson II Farm was designated as a national historic landmarks, along with three other notable sites: The *Detroit Industry* Murals by Mexican artist Diego Rivera at the Detroit Institute of Arts in Michigan, the George Nakashima Woodworker Complex in Pennsylvania, and the 1956 Grand Canyon TWA-United Airlines Aviation Accident Site at Grand Canyon National Park in Arizona.

"These four new national historic landmarks are as diverse as our American heritage, telling stories of triumph and tragedy, of dedicated service and artistic beauty," said U.S. Secretary of the Interior Sally Jewell. ... continued on page 2


### **VILLAGE COFFEE!**

Adlai Stevenson was nominated twice as a candidate for the presidency and served as a United Nations Ambassador, playing a key role in mid-20th century Cold War politics. His Mettawa farm was his home for most of his adult life, and is closely associated with many of his important activities.

### New: **Open Space Advisory Committee**


The Board of Trustees has approved the formation of an new Open Space Advisory Committee (OSAC). Its mission is to to assist in the selection of an open lands planner, and to help form open lands plans for the Village. OSAC will report directly to the Board on matters regarding Mettawa's open space and its management, offering ideas, input and oversight. Thank you to these dedicated volunteers for their personal commitment to open space.

### Open space planning

The Zoning, Planning and Appeals Commission has been working with Village Administrator Bob Irvin to create a new open space zoning district which will provide stronger protection to current and future open lands within the Village in an effort to protect Mettawa's rural character.



### Parks & Recreation update

Whippoorwill Park The Board approved a proposal by Teska to plant trees and bushes on the berm, and this work is currently going out for bid.

**Oasis Park** The construction of the Oasis Park berm continues, and we expect it to be completed by June.

Hay for residents The triangular 19.01-acre property recently acquired by the Village (bordered by I-94 and Riverwoods Blvd.) has been historically cut for hay. The Village plans to continue this tradition by cutting the hay and offering it for sale to residents.



### **Public Works updates**

Riverwoods Road This year expect to see construction activity on Riverwoods Road between Costco and Everett Road (exact starting date to be determined). The Lake County Division of Transportation will widen the shoulders and add walking paths on each side. This project will cause some short-term inconveniences, especially to nearby residents, but we are hopeful

that these improvements will increase safety.

**Bradley Road** The repaying of Bradley Road has gone out for bid, and the estimates will be presented at the May 2014 Board of Directors meeting.

Mettawa Trail The Board has approved extending the Mettawa Trail west to St Marys Road along Route 60 from its current endpoint at the western border of Deerpath Farm. James Anderson Company will design and engineer the trail, and the Village will be reviewing the project with the Illinois Department of Transportation. Mettawa has applied for a \$10,000 ComEd grant to help cover the project's costs.

**Village Hall** Discussions about the possibility of a new Village Hall continue. Bob Irvin has been researching requirements and success stories of other small communities, and the Board approved the creation of a preliminary design study by Frederick Phillips and Associates.

Railroad Crossings The railroad crossing at Old School Road will soon be repaired and improved by its owner, Canadian National. Timbers with high spots will be milled down to make the crossing more even, and any irreparable timbers will be replaced. The company will also inspect the crossing at St. Mary's and make any necessary repairs.



### Administrator's report

I am pleased to report that the Village of Mettawa continues to make good progress from both organizational and financial standpoints. Perhaps most significantly, our new budget has been completed and was

approved by the Village Board at its April meeting. It was a pleasure to work on this budget with the Mayor and Village Board, and we expect that it will help keep the Village in excellent financial standing.

During the past three months, I've been working on developing stronger and more effective agreements with our vendors and with Lake County. We now have a newly revised six-month contract with the Village engineer, James Anderson Company. The terms of this new agreement should significantly reduce Village engineering costs, and will be reviewed and evaluated at the end of the six-month time period.

The Village Hall continues to be a topic of discussion, and I've heard many good ideas about how to proceed if the Village decides to build a hall. Many quite successful halls have been built for other small municipalities, and they are happy to share learnings from their experiences. I have been visiting small village halls that are now in use in other local communities, such as Deer Park and Bannockburn, in an effort to find the most functional solutions. If we build a Village Hall, it should be designed to fulfill our current and future needs.

I've also been working with the Village Attorney and Zoning and Appeals Commission to review options for the creation of a new open space district. As many residents have expressed, the language describing the Special Services Areas (SSAs) in Mettawa can be difficult to understand. I've reviewed all of the SSAs and have created new, simpler summaries that should be easier to understand. Please feel free to contact me with any questions.
